**PLAINTIFFS’ UNOPPOSED MOTION FOR COURT PERMISSION TO USE
ELECTRONIC MEDIA EQUIPMENT**

Plaintiffs, by and through undersigned counsel, hereby move the Court for an order allowing the use of computer equipment for the evidentiary hearing on Defendants’ Motion to Dismiss for Insufficient Service Of Process Or, In The Alternative, Extend Time to Answer Or Respond To Complaint scheduled for August 23, 2016. In support, Plaintiffs state:

1.
