I, Employee Doe, declare as follows:

1. I am an employee at Beck & Lee, P.A., one of the Plaintiffs' law firms.
2. I am the employee at Beck & Lee, P.A. who answered the phone on June 1, 2017 when a voice-masked caller called the office [Dkt. Nos. 55, 56].
3. I make the following representations based on my own knowledge, and what was told to me directly by my mother.
4. On June 2, 2017, my mother received a visit at her home by an unknown woman. I was not there at the time.

5. When my mother answered the door, the unknown woman specifically asked for me by my full name.

6. The unknown woman left a "Florida Democratic Legislative Campaign Committee" Vote-By-Mail Application, attached hereto as "Exhibit A."

7. I am registered as "No Party Affiliation."

8. The unknown woman did not visit any other house on the block, although she had a stack of the forms provided to my mother.

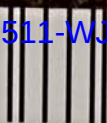
