STIPULATION OF STAY PENDING ARBITRATION BRIEFING

Plaintiff Jose Mejia (“Plaintiff”) and Defendant Uber Technologies, Inc. (“Uber” or “Defendant”) (collectively, the “Parties”) file this stipulation. The Parties hereby agree to the following.

1. Uber’s Motion to Stay Proceedings Pending Determination of the Motion to Compel Arbitration (DE 13) should be granted.

a. Plaintiff has indicated that he may seek discovery on the issues of arbitration as set forth in Uber’s Motion to Compel Arbitration and Stay All Proceedings (“Motion to Compel”) (DE 11).

b. Uber does not agree that Plaintiff is entitled to seek such discovery but will agree to address that issue with the Court if and when the issue arises.

2. The parties are filing on September 29, 2017, a joint scheduling report pursuant to the Court's Orders (DE 9, 14).

3. Plaintiff will file an Unopposed Motion for Enlargement to respond to Uber's Motion to Compel to November 30, 2017. By not opposing this request, Uber does not agree that Plaintiff is entitled to seek discovery of arbitration issues as noted above.
