Hi Beverley:

We apologize for the delay in getting back to you on the Rule 16 conference. We had hoped to discuss the following issues on the phone but have been told that all of your attorneys are tied up.

In any event, your client signed a binding, mandatory arbitration agreement which we will be enforcing. As such we will be objection to participating in any Rule 16 conference as inconsistent with the arbitration clause.

Pursuant to S.D. Fla. L. R. 7.1(A)(3), we thus would like to obtain your position on Uber moving to compel arbitration in this matter. To this end, we have confirmed that Plaintiff entered a Technology Services Agreement with Rasier-DC, LLC, Uber's wholly owned subsidiary, that contains a valid Agreement contains a valid and enforceable arbitration provision (attached). Uber is specifically designated as an intended third-party beneficiary for the arbitration provision.

As is clear under the arbitration provision, Plaintiff agreed to resolve any and all disputes arising out of or related to his relationship with Uber in arbitration. Plaintiff further agreed to resolve any claim he may ever have against Uber on an individual basis, thus precluding him from bringing or participating in any class, collective, or representative action such as the one he purports to bring here. Several federal courts, including courts in this District, have upheld the same or similar arbitration provisions. Thus, because Plaintiff's claims are covered by the arbitration provision, we intend to seek to say this case pending arbitration and to strike the class allegations. Please let us know if you oppose.

Finally, we also intend to move to stay this action pending the resolution of our motion to compel arbitration. In short, it would be inconsistent with the parties' agreement to arbitrate to engage in any further litigation in the case. Please also let us know if you oppose a motion to stay. We also will ask the court for an alternative enlargement of time to file a motion to dismiss pending the resolution of the arbitration motion. Please also lets us know if you oppose that relief.

Ed is in arbitration. Hannah should be back from mediation tomorrow and I am in the office should you need to discuss any of this.
